Thailand Boxing Association takes great pleasure to invite your national Elite Men boxing team to participate in **The Thailand Open International Boxing Tournament 2020**, which will be held in Pattaya, Thailand on 2 – 9 April, 2020.

1. Competition Rules:

The Thailand Open International Boxing Tournament 2020 will be staged according to AIBA Rules. All bouts will be based on 3 rounds of 3 minutes each with 1 minute break between the rounds.

2. Weight Categories:

All National Federation are eligible to send ONE elite boxer in each weight category to participate in the competition (NO substitution) in **11** weight categories (Men 6 Weight categories, Women 5 Weight Categories):

Men (6 Weight Categories) 52, 57, 63, 69, 75, 81 kg.

Women (5 Weight Categories) 51, 57, 60, 69, 75 kg.

3. Competition Team Composition:

• 1 - 11 boxers + 3 coaches + 1team manager + 1 official + 1R&J (AIBA Star)

Only 1 boxer in each weight category

Each boxer must bring his AIBA record book to the weight-in. A boxer will not be allowed to compete without the record book.

Delegations are requested to bring two national flags $(2m \times 1m)$ and CD (or Flash Drive) of their national anthem.

5. Financial Conditions:

- Accommodation and meals for the official team will be provided by the hosting federation ACCORDING TO THE COMPETITION TEAM COMPOSITION (mentioned in no.3)
- Extra person must cover all their expenses by themselves Accommodation and meals:110 USD per person per day.
- Each person will have to pay 110 USD for early arrival or/and late departure.
- Each Participant (Boxers, coaches, Officials, Manager, etc) have to pay 40USD/person for registration fee.
- The Organizing committee will provide local transportation.

6. Visa:

Visa support letters will be provided for participants who need entry visa to Thailand. Please contact the Organizing Committee and send passport copies, list of delegation and name of a city where you will apply for visa. Email: tba.kanyata@gmail.com

7. Medals and Certificate:

Gold, Silver, 2 Bronze medals and diplomas will be awarded in each weight category. *CASH PRIZE WILL BE AWARDED*

8. Medical care:

The Organizing Committee will provide medical care and first-aid for all participants who will sustain sports injury during the entire tournament. All participants must have their own travel, medical insurance for non related competition's injury.

9. Doping Control:

Doping Control will be conducted according to the World Anti-Doping Code. Doping Control procedure will be developed according to the International Standard for Testing.
