PA Sport Boxing Club named in honor of Ural and Korgan Aitenov has the great privilege to invite your National Youth Boxing Team to participate in the «**XXIII International Youth Boxing Tournament In Memory of Ural and Korgan Aitenov**», which will be held on **July 17-23, 2023, in Kostanay, Kazakhstan.**

### Goals and Tasks

- ✓ Development and popularity of boxing in Kazakhstan
- ✓ Development of international sporting relations between our countries
- ✓ Exchange of boxing practices with the strongest boxers
- ✓ Winner will receive Championship Title of Kazakhstan

### Dates and Venue

- ✓ Tournament will be held on July 17-23, 2023, in Kostanay (city), Kazakhstan (country).
- ✓ Date of arrival: July 17, 2023
- ✓ Date of departure: July 23, 2023

### Conditions of participation

- ✓ Competition will be staged in **13** weight categories according to IBA Rules **48 kg, 51 kg, 54 kg, 57 kg, 60 kg, 63,5 kg, 67 kg, 71 kg, 75 kg, 80 kg, 86 kg, 92 kg, + 92 kg.**
- ✓ Composition of a team: **5 boxers, + 1 coaches, + 1 referee.**
- ✓ Only **1** boxer in each weight category has the right to participate, and must have been born in between **2005-2006.**
- ✓ Each boxer and referee must bring valid International IBA record book with annual medical examination and passport to the weigh in
- ✓ Bouts will consist of 3 rounds (three minutes each) with 1 minute break between each rounds
- ✓ Participants must have competition tanks and boxing shorts
- ✓ All of the boxers must have first category of boxing or above
- ✓ Each boxer must have 1) passport of his country 2) insurance policy 3) boxing annual medical examination certificate 4) IBA PASSPORT 5) MRI of the brain

### Financial responsibilities

- ✓ Team will be responsible for purchasing tickets for arrival to Kazakhstan (Kostanay) and return transportation back home

- ✓ If a team arrives earlier than July 17<sup>rd</sup> or stays after July 23<sup>rd</sup> they will be responsible for accommodations and meals, \$45 for each person per day
- ✓ Hotel, transportation, meals will be sponsored by Ural and Korgan Aitenov Sport Boxing Club

**Awards**

- ✓ Gold, Silver and 2 two Bronze Medals, Diplomas along with prizes will be provided to the winners in each weight category

**Registration and Deadlines**

- ✓ Final entries, passport copies and fight details must be sent to the Organizing Committee before June 5, 2023
