

SECTION 5. Composition of Sports Delegations

- 5.1. Kyrgyz Republic's sports delegation: 3 teams of boxers, 4 coaches.
- 5.2. Delegation from invited countries: 1 team of boxers, 2 coaches, 1 ITO referee.
- 5.3. Doubling of boxers in weight categories is not allowed.
- 5.4. The Referee Panel consists of 36 members.

SECTION 6. Tournament Conditions

- 6.1. The International Tournament is conducted according to the current international rules.
- 6.2. Men's weight categories: 46-48 kg, 48-51 kg, 51-54 kg, 54-57 kg, 57-60 kg, 60-63.5 kg, 63.5-67 kg, 67-71 kg, 71-75 kg, 75-80 kg, 80-86 kg, 86-92 kg, +92 kg.

SECTION 7. Protest Procedure

- 7.1. Protests are submitted by the official team coach to the Tournament's Technical Delegate within 60 minutes after the fight, specifying the violated rule.
- 7.2. Protests are considered only with a guarantee fee of USD 500.
- 7.3. The fee is refunded if the protest is upheld; if rejected, the amount is non-refundable.
- 7.4. Protests are reviewed by the appeal jury after the competition program ends with mandatory video review of the fight.

SECTION 8. Hosting Conditions

- 8.1. All expenses for travel to and from Bishkek, accommodation, and meals for participants are borne by the delegating organizations.
- 8.2. The Organizing Committee provides:

- Accommodation and meals for officially invited participants from April 28 to May 4;
- Medical services during the competition;
- Police duty;
- Video recording of all fights;
- Production of medals, certificates, and banners;
- Award ceremonies;
- Payment for judges, medical staff, and technical personnel.

SECTION 9. Awards

- 9.1. Winners and prize-winners of the tournament are awarded medals, diplomas, and prizes.
- 9.2. The best participants in nominations ("Best Coach", "Best Boxer", and "Best Referee") will receive memorable prizes.

SECTION 10. Anti-Doping Policy

- 10.1. All participants must comply with the anti-doping rules of the Kyrgyz Republic and WADA. In case of violation, the athlete may be disqualified.

SECTION 11. Tournament Management

- 11.1. The tournament is managed by the Organizing Committee consisting of representatives of DoOS and the National Boxing Federation of the Kyrgyz Republic.

SECTION 12. Submission of Applications
